

Being an Election Judge

You will be in charge of the full operation of your polling site; Must be present all day

Judge will need to contact the polling site to set up with a meeting time on election morning

You are responsible for pick up and delivery of election

supplies

Designate duties for clerks

 Judge <u>must</u> treat ALL clerks with equal respect with designating working hours and assigning duties (Sec. 32.072(c) TX Election Code)

 May appoint special peace officers, as needed, to preserve order

A Few Tips for EVERY Election...

- A voter may bring in material to assist them in voting, but they must leave with it
- NO political advertising of any kind is permitted (hats, shirts, buttons, ect)
- NO cell phones
- DO NOT give a voter an access code unless there is an open booth

Who is allowed in the Polling Place?

Who is NOT allowed in the Polling Place?

- Candidates
 - Unless voting or conducting official business in the building
- Bystanders
 - People who are not in the polling place to vote or for one of the other permitted reasons

What is Electioneering?

Advocating for or against a candidate, measure, party or issue within the protective legal boundary surrounding a polling place



- 100 ft. from any outside door of the building
- Amplification device is 1,000 ft. from building
- Judge may <u>not</u> enforce outside the 100 ft. marker
- Class C misdemeanor

Electioneering

- What if someone is electioneering?
 - Presiding Judge has responsibility to ensure safe, confidential voting
 - Judge may ask a disruptive person to leave
 - -If a voter, they must be given the opportunity to vote before removal from polling place
- What if they won't stop?
 - The Judge may summon a peace officer





Layout of the JBC






NOTICE

Prohibition of Certain Devices Within 100 Feet of Voting Stations

Persons are not allowed to use a wireless communications device within 100-feet of the voting stations. Additionally, persons are not allowed to use a mechanical or electronic device to record sound or images within 100-feet of the voting stations. Said devices include but are not limited to cell phones, digital phones, cameras, phone cameras and sound recorders. A voting station is the area where the voter masts the ballot.

The election judge has the authority to require persons to deactivate any such device and further authority to require persons who do not comply to leave the polling place.

Poll watchers are subject to additional rules and must sign an oath stating they do not have in their possession, mechanical or electronic devices that record images or sound.

Questions or clarification should be directed to the election judge in your polling place.

Note: This does not apply to election officers conducting official duties or the use of election equipment necessary for the conduct of the election.

With the exception of the U.S. citizenship certificate, the identification must be current or have expired no more than 60 days before being presented for voter qualification at the polling place.

Exemptions - Voters with a disability may apply with the county voter registrar for a permanent exemption. The application must contain written documentation from either the U.S. Social Security Administration evidencing he or she has been determined to have a disability, or from the U.S. Department of Veterans Affairs evidencing a disability rating of at least 50 percent. In addition, the applicant must state that he or she has no valid form of photo identification. Those who obtain a disability exemption will be allowed to vote by presenting a voter registration certificate reflecting the exemption. Please contact your voter registrar for more details.

Voters who have a consistent **religious objection** to being photographed and voters who do not have any valid form of photo identification as a result of certain natural disasters as declared by the President of the United States or the Texas Governor, may vote a provisional ballot, appear at the voter registrar's office within six (6) calendar days after election day, and sign an affidavit swearing to the religious objection or natural disaster, in order for your ballot to be counted. 

- Judge will add voters name on the Combination form (if not already on the combination form) and have voter sign.
- Judge will add voters name on the List of Provisional Voters and on the Registration Omissions List and check the Sworn box.
- Judge then adds the voter on the JBC and selects the precinct number of that voter. (See page 19 in your Ref. Manual)
- On the next screen, press the arrow next to PROVISIONAL and then press the arrow next to YES.
- Press the arrow next to PRINT, and the Provisional ballot stub will print from the JBC.
- JUDGE MUST WRITE <u>RETRIEVAL CODE</u> ON TOP-RIGHT SIDE OF AFFIDAVIT.
- Voter must sign and print his/her name at the bottom of the Provisional ballot stub.
- Uvoter tears off the access code to be used in the voting booth.
- Voter places the Provisional ballot stub into the Affidavit for Provisional Ballot envelope and seals the envelope. (Judge does NOT touch the Provisional ballot Stub).


